# Guiding Principles

---

- THERE IS NO INTENDED PRIORITY OF GUIDING PRINCIPLES
- SOME GUIDING PRINCIPLES MAY OVERLAP
- SOME GUIDING PRINCIPLES MAY CONFLICT
- SOME ASSIGNMENT SOLUTIONS MAY NOT REALIZE GUIDING PRINCIPLES TO THE FULL EXTENT
- GUIDING PRINCIPLES ARE DEPENDENT ON THE SCHOOLS IMPACTED BY THE ASSIGNMENT PLAN

## BALANCE

To the extent possible, the assignment proposal should provide balance in: building utilization, program opportunities, and student demographic factors.

## PLANNING

To the extent possible, the assignment proposal should utilize up-to-date school and planning data to provide a stable assignment plan that is forward-looking and responsive to community and student needs.

## EFFICIENCY

To the extent possible, the assignment proposal should seek to optimize operational efficiency.

## COMMUNITY

To the extent possible, the assignment proposal process should promote transparency and be sensitive to the needs of our families, communities and the district.

# Process

---

- Data
  - **Student data – MCS student geocodes for 2015-16 through 2018-19.** Geocodes carry student information such as address of domicile, attended school, grade and proficiency indicator.
  - **GIS data – MCS geo-database.** The geo-database is the platform for exploring attendance area scenarios. The geo-database contains school and student data including base elementary/middle/high school attendance areas, student counts, forecasted student counts and proficiency metrics.



# Process: Advisory Committee

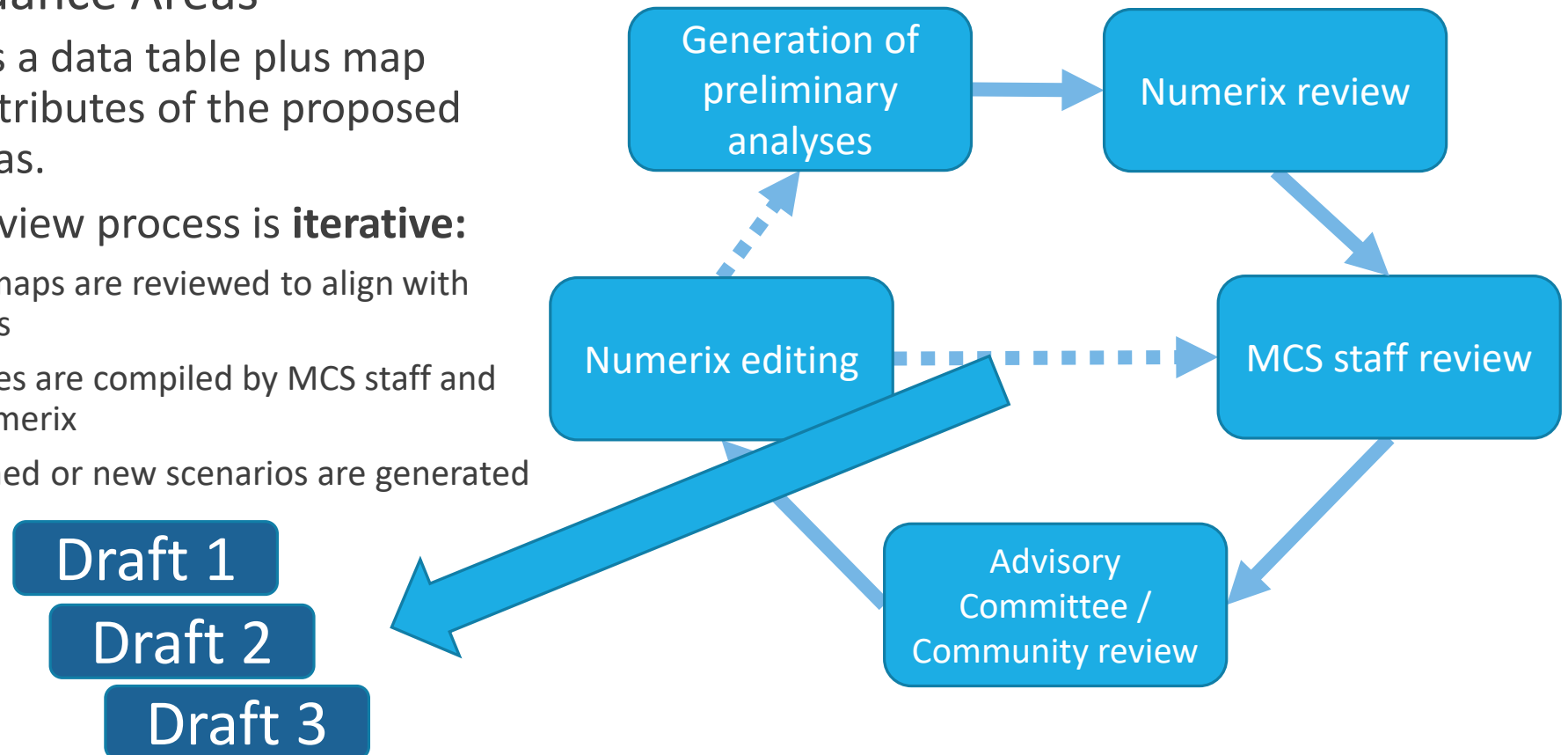
---

- Membership includes district staff, consultants, principal, teacher and parent from each school in county except high schools and Pinckney Academy. One team represents both Aberdeen and Southern Pines primary and elementary schools since they will be consolidated.
- Sub-committees for each feeder area are chaired by respective high school principal.
- Committee will participate in development of each of the three drafts of the plan.

# Process

- Creating Attendance Areas

- An “scenario” is a data table plus map summarizing attributes of the proposed attendance areas.
- The scenario review process is **iterative**:
  - Data tables and maps are reviewed to align with Guiding Principles
  - Suggested changes are compiled by MCS staff and forwarded to Numerix
  - Edits are performed or new scenarios are generated



# Process

---

- Guiding Principles are primary factors in shaping attendance area scenarios:
  - **Impact Area** – Scenarios are holistic; they can potentially impact all schools.
  - **Future Schools** – Scenarios include impacts from the planned opening of three schools.
  - **Utilization** – Scenarios attempt to balance utilization among impacted schools.
  - **Transportation** – Scenarios attempt to address obvious transportation/accessibility issues.
  - **Proximity** – Scenarios attempt to assign students to the closest school.
  - **Proficiency** – Academic proficiency will be reported for all scenarios: EOG ELA and Math for grades 3-8 over school years 2015-16 through 2017-18.
- Scenarios are a starting point for the exploration and analysis of potential attendance areas and subject to revision at the request of MCS staff and Board of Education.

# Desired Outcomes for the Student Assignment Plan

---

- Develop assignment plans for three Elementary Schools opening 2020-21 and 2021-22
- Resolve unfinished business from 2019-20 Area I assignment plan
- Address, to the extent possible, utilization issues among elementary and middle schools
- Balance, to the extent possible, demographics among elementary and middle schools

# General Comments from the Advisory Committee Meeting

---

- Consider expanding the lines for Area II (North Moore HS) to accommodate feeder patterns and improve utilization
- Consider combining elements of preliminary utilization-driven and stability-driven analyses
- Concern about increased bus travel time resulting from balancing utilization
- Concern around the potential need for additional buses and drivers and the inability to meet that need
- Utilization and demographic balance concerns around the Pinehurst, West End, West Pine area
- Desire to see greater balance of demographics and proficiency across the district
- Concern about the predicted growth at Vass-Lakeview; Cameron may be used to alleviate expected crowding
- Suggestions for improving map presentation

# MCS Multi-Year Student Assignment Plan Draft 1

---

- Draft 1 is based on balancing district-wide utilization for elementary and middle schools and maintaining elementary to middle and middle to high school feeders to the extent possible. Draft 1 assumes the new Aberdeen area and Southern Pines area elementary schools open in 2020-21 and the new Pinehurst ES opens in 2021-22. All new elementary schools have capacity = 800.
- Draft 1 assumes a modular classroom unit will be moved to Cameron ES by 2022-23, increasing Cameron's capacity to 400 seats
- The target year for Draft 1 maps and data tables is 2022-23 after all changes are in place

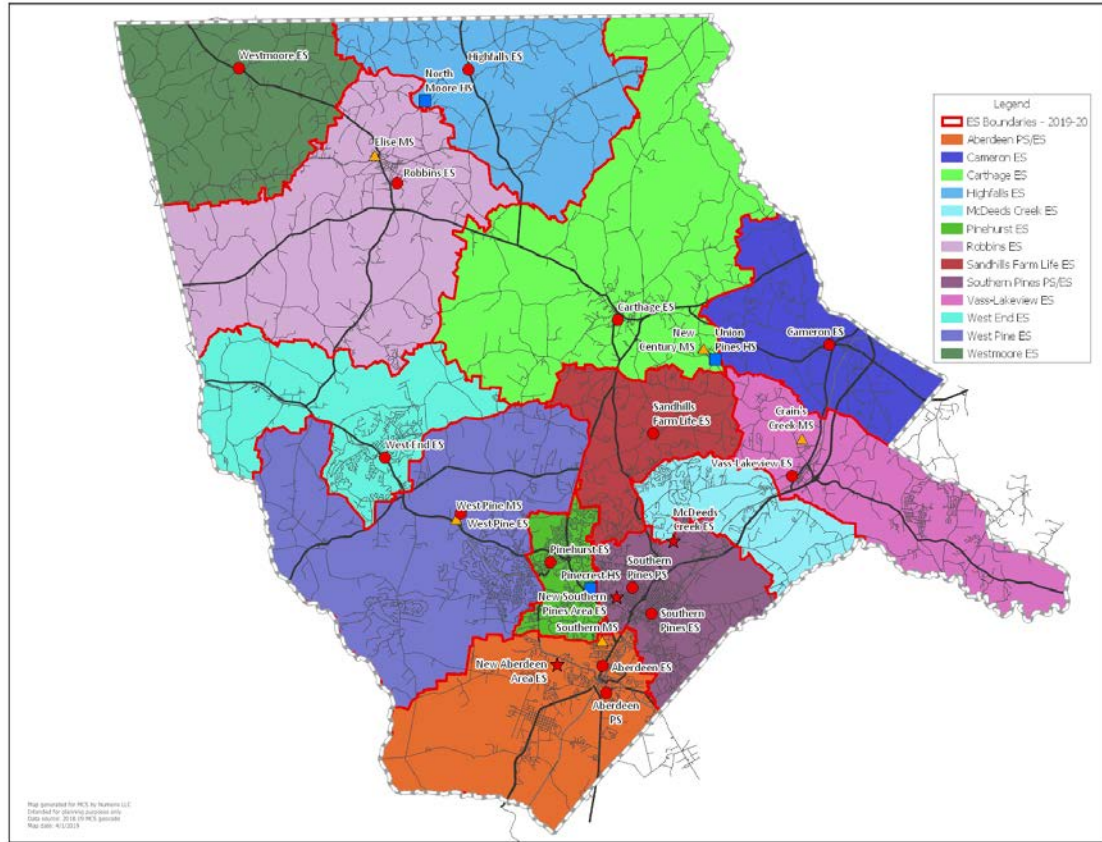

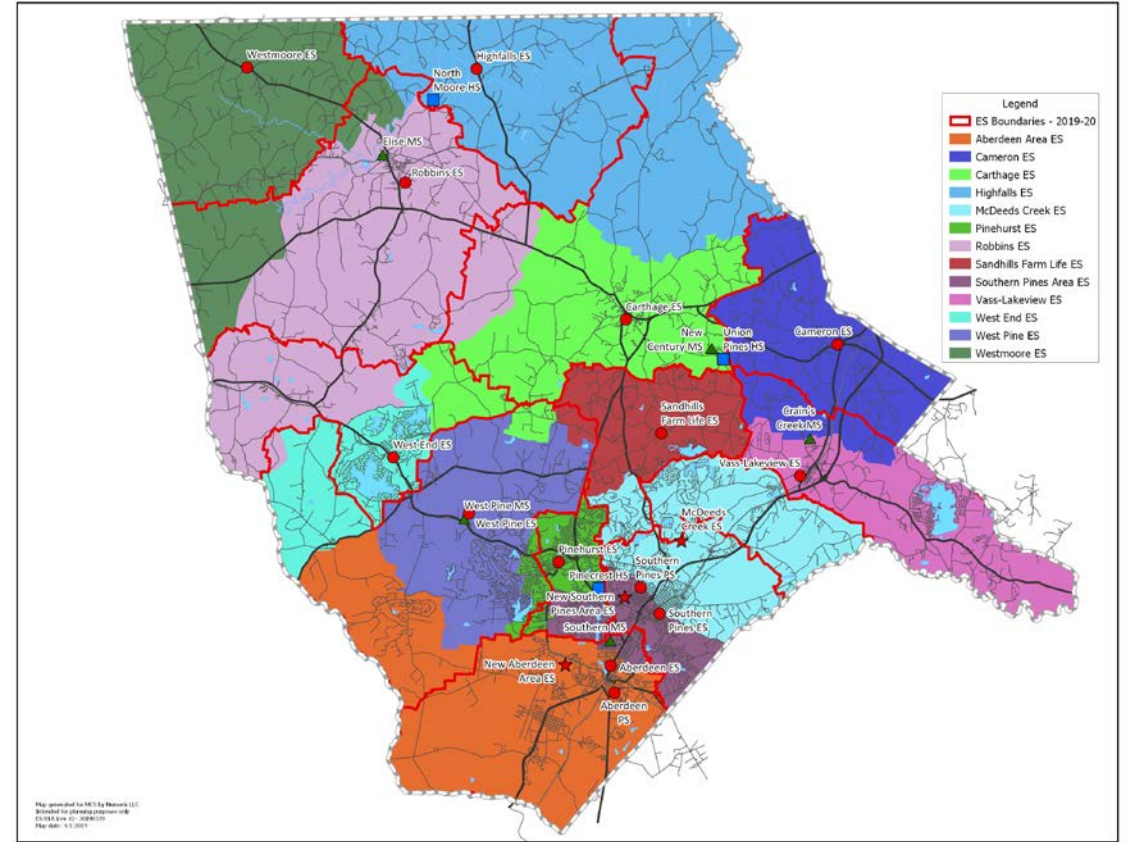

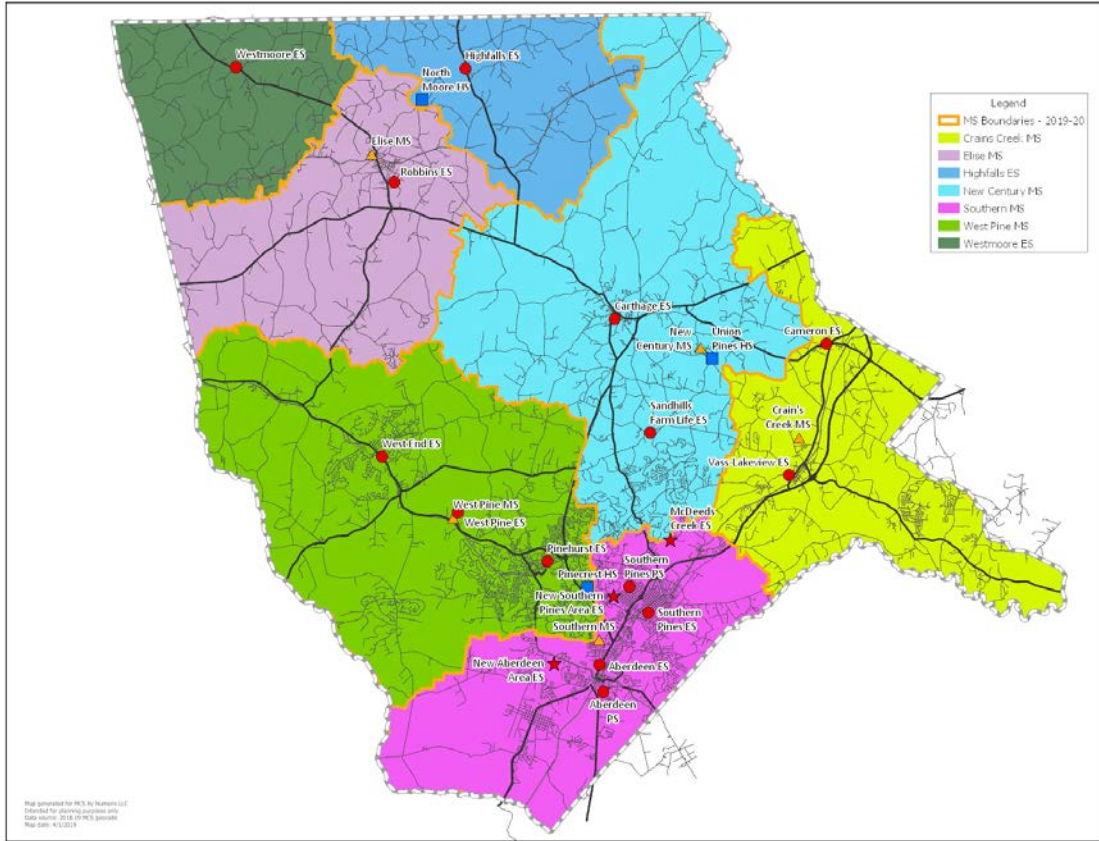

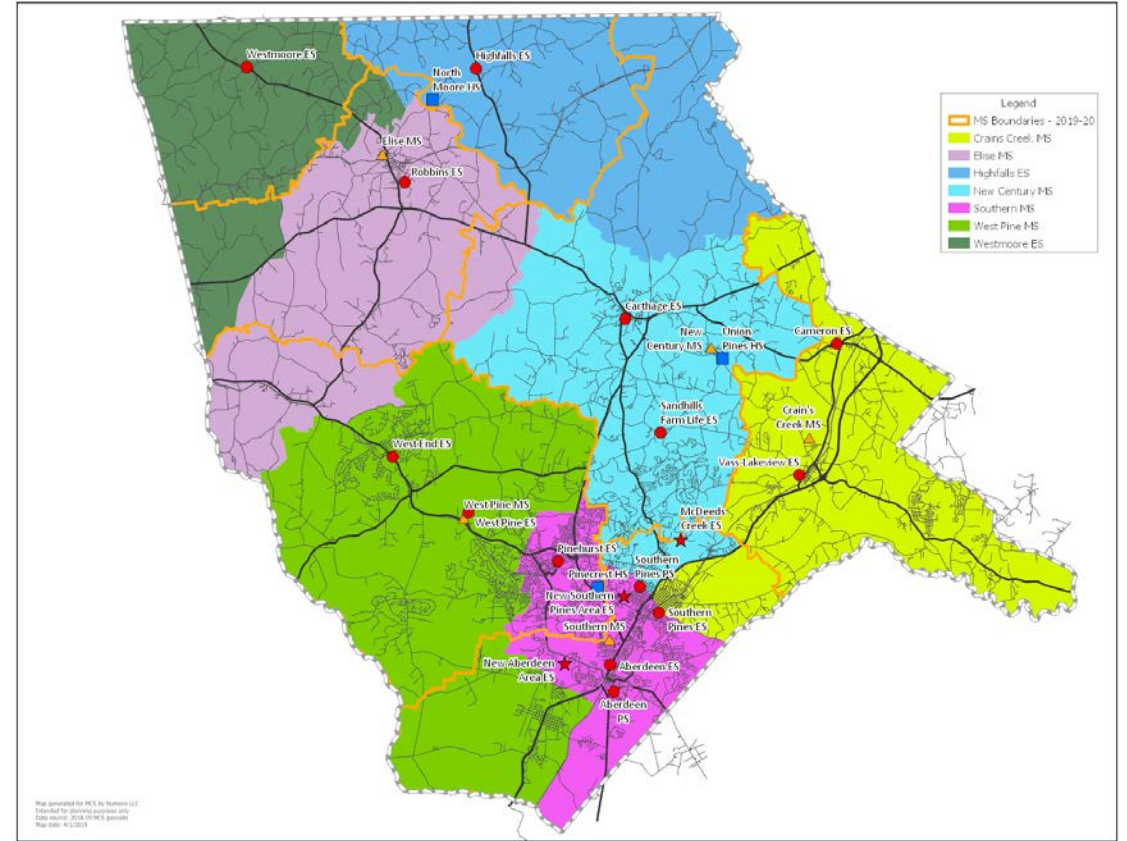

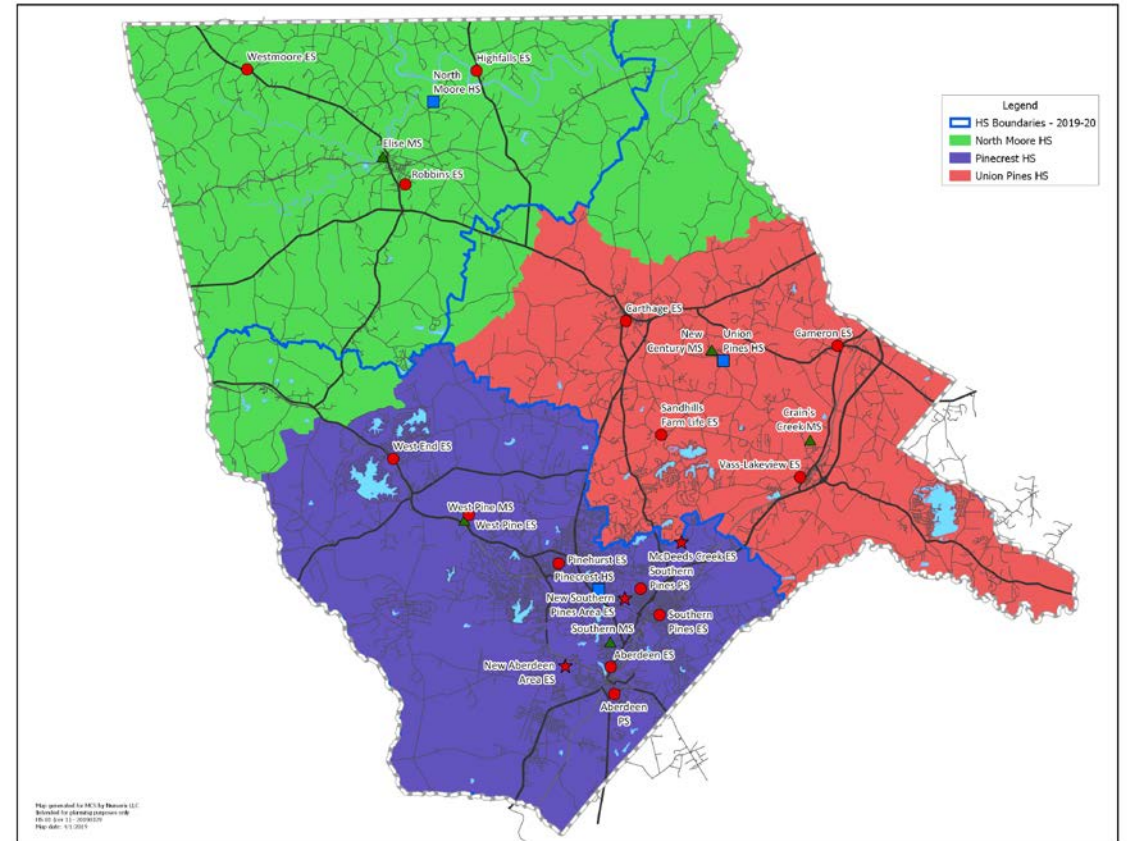

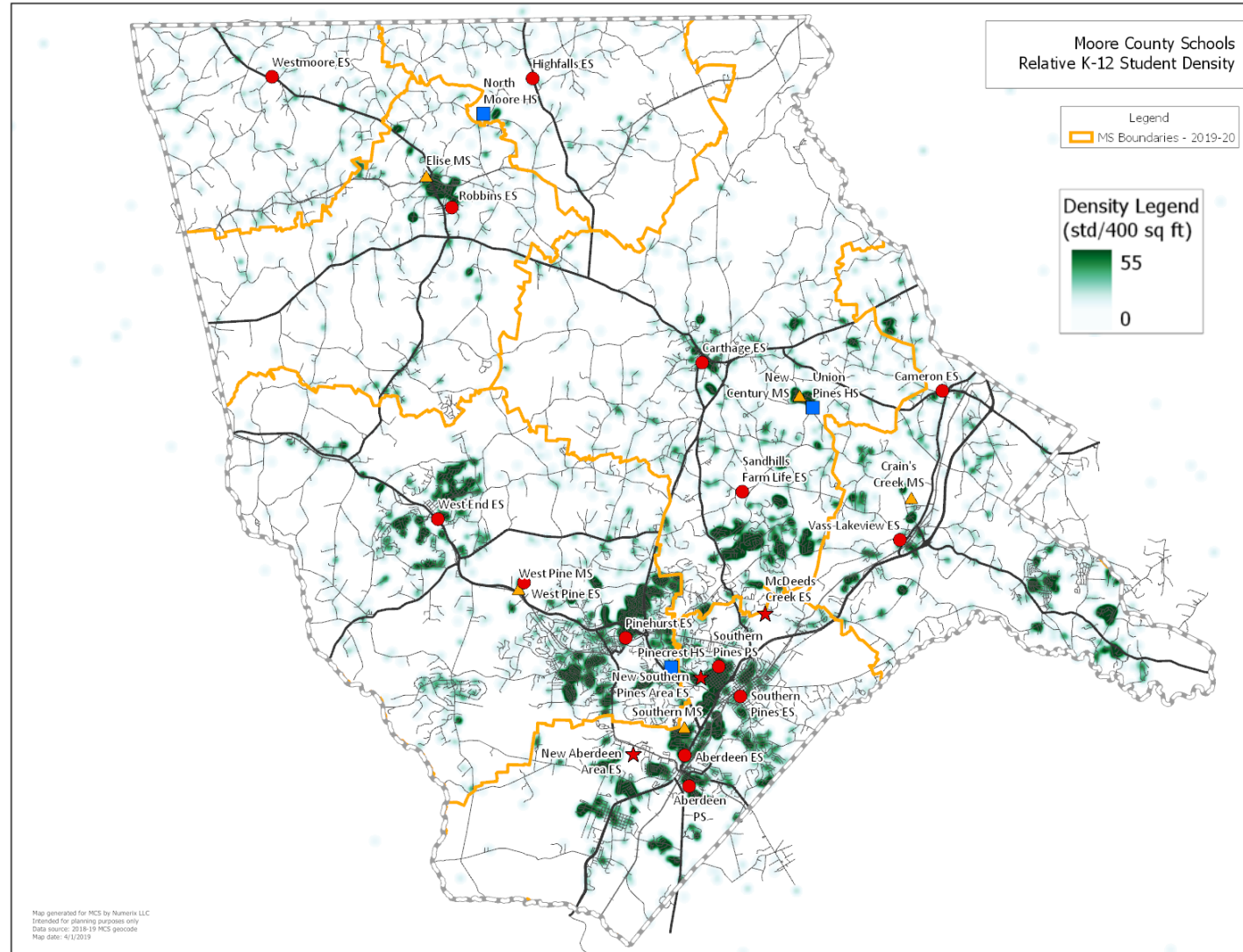


# Student Density by Residence – ES Base

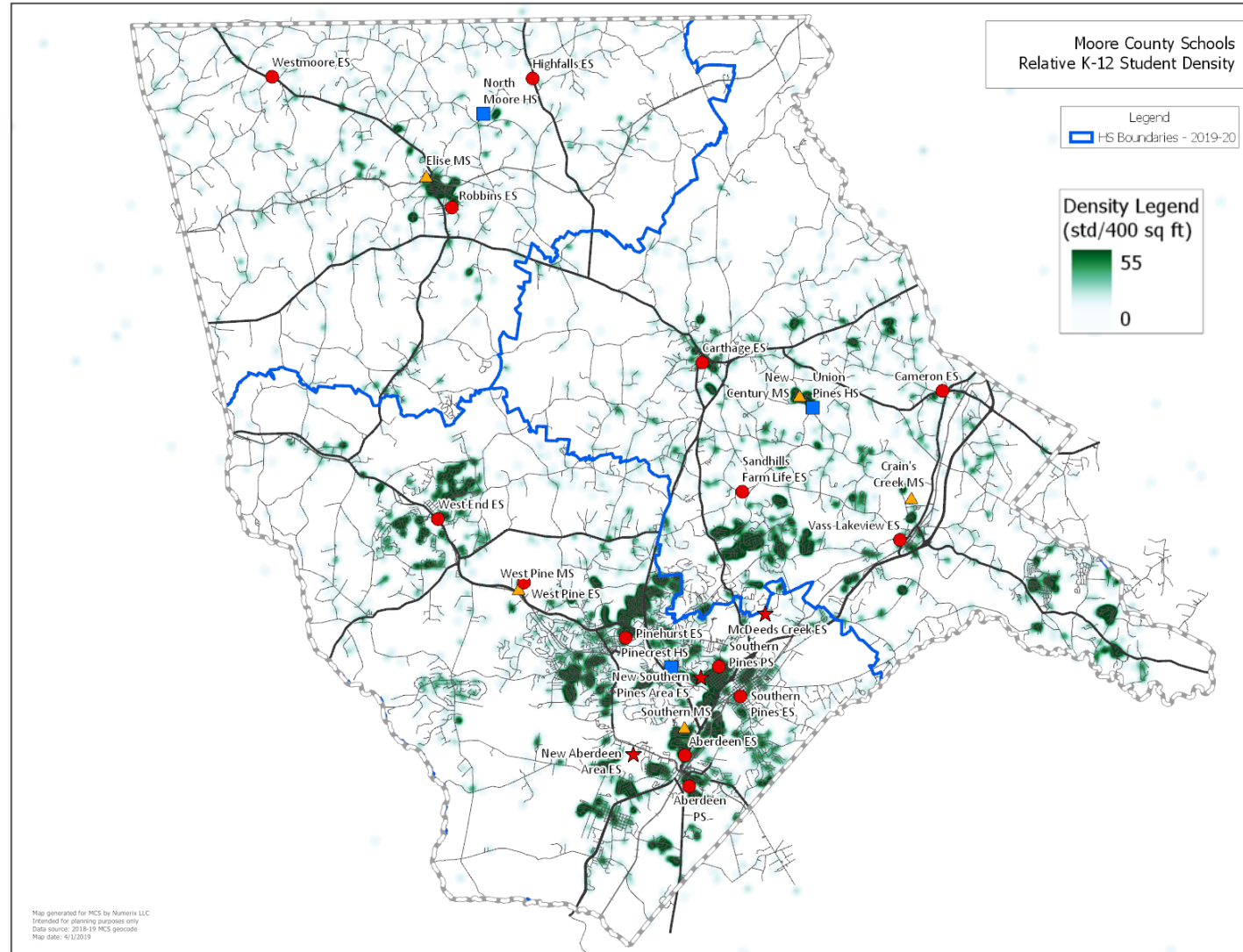




# Student Density by Residence – MS Base
